

## DIRECTIONS FOR USE:

Measuring cups are provided with **FUNGURAN-OH** to enable the user to measure the correct amount of product into a 20 Litre Debe or Knapsack Sprayer.

When preparing the spray mixture it is advisable to mix the required amount of **FUNGURAN-OH** into a smooth thin paste with a small quantity of water in the bottom of the Debe. Then add the correct quantity of water and stir well before pouring into the Knapsack Sprayer.

Ensure even spray coverage of the target crop. All surfaces of the foliage must be covered to prevent disease developing.

## COMPATIBILITY

**FUNGURAN-OH** is compatible with many fungicides and insecticides e.g. FENITROTHION, CHLOROTHALONIL, PROPICONAZOLE, DITHIANON, DELTAMETHRIN.

## PRECAUTIONS

Do not inhale powder or spray mist. Avoid contact with skin or eyes. Do not swallow. Prevent spray drift on to other crops, areas not under treatment or into rivers or dams.

## FIRST AID IN CASE OF POISONING

Wash skin with soap and water and wash eyes copiously with water.

## STORAGE INSTRUCTIONS

Store under dry conditions and avoid excessive heat.
