GENERAL INFORMATION

Hot Sauce Animal Repellent is a water-miscible, highly concentrated extract derived from hot peppers. Animals attempting to feed upon treated plants or other items are unlikely to be harmed. A warm sensation which the product is believed to cause in the throats of these animals may discourage feeding in situations where the animals have freedom to select other foods. Vapor Gard, an anti-transparent film former, may prolong the effective life of Hot Sauce Animal Repellent by reducing the effects of weathering factors. Vapor Gard is a registered trademark of Miller Chemical & Fertilizer Corporation. Uses on ornamentals, fruit and nut trees, bushes and vines. To repel buck, rabbits and domestic animals that feed upon ornamental trees and shrubs, dormant fruit and nut trees, fruit bushes and vines. Uses on crops. To repel buck, rabbits and domestic animals that feed upon beans, brussels sprouts, cabbage, cauliflower, corn, cotton, cucumbers, melons, peas, peppers, squash and tomatoes.

IMPORTANT!

Use restrictions: Limit applications on fruit-bearing plant up to the period before fruit sets or up to the period after fruit has been harvested. Applications may be made from the time of seedling emergence until the time when edible portions of plant begin to form. Applications to cabbage and cauliflower must be made before the heads start to form. Applications to cotton must be made before the bolls start to form. Do not apply this product through any type of irrigation system. Do not use treated foliage for animal bedding or feed. This product will not affect subterranean damage by moles to trees, bushes and vegetable crops.

Mixing directions:

General: Thoroughly mix 180 to 250ml of Hot Sauce Animal Repellent in 5L of water. In a second container, mix 2L of Vapor Gard in 5L of water. Stir contents of each container until they are mixed thoroughly. Add the pre-mix to an amount of water sufficient to make 400L of mix. It is important to pre-mix Hot Sauce Animal Repellent and Vapor Gard separately with water before they are added to the bulk of the water in the spray tank or other vessel. Maintain agitation in the spray tank. If lesser amounts of mix are needed, combine ingredients at rates of 10 to 15ml of Hot Sauce and 250ml of Vapor Gard for each 50L of water.

Application directions: Apply as a full cover spray to tree trunks, branches, and foliage where feeding by buck, rabbits or domestic animals occurs or is expected to occur. For trees and large bushes, apply 400 to 1000L of spray solution per hectare. For row crops and small bushes, apply 100 to 400L of spray solution per hectare. For aerial application apply 30 to 40L of spray solution per hectare. Repeat treatment if animals begin to feed on treated plants. The dosage can be doubled to repel animals that were not affected by the first application.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Storage: Store in tightly closed, original container in a locked area away from children and domestic animals.

Product disposal: Waste resulting from the use of this product may be disposed of on site or at any approved waste disposal facility.

Container disposal: Rinse empty container three times with a volume of water equal to at least one tenth of that of the concentrate and add the rinsings to the contents of the spray tank. Destroy empty container and do not re-use for any other purpose.
