General Information: PIANTVAX 20 EC is a systemic follar applied fungicide recommenced for use against rust in wheat, barley, vegetables and ornamentals. The Oxycarboxin belong to the Oxathin chemical family. PLANTVAX 20 EC has systemic action and does not just stay on the plant surface. Through its systemic action. PLANTVAX protects the plant from inside, thus overcoming effects of weathering and wash-off. Soil treatments with PLANTVAX have also been successfully employed to control rust diseases.

Application: PLANTVAX 20 EC is to be applied as a full cover spray on all foliage parts.

Timing of application: The optimal application time for PLANTVAX 20 EG is dependent on the level and the diseases presents. Apply PLANTVAX 20 EC when first sign of disease is seen and during the early stages of interior. Users of PLANT-VAX 20 EC are advised not to apply the product when the crop is under status, as this will not give good results.

Crop tolerance: Plantvax 20 EC is well tolerated by crops listed on the label, when used as recommended. Mixing: Half fill the tank with clean water and add the required amount of PLANTVAX 20 EC EC into the spray tank with the

Storage: Store in the original, tightly closed container in a cool, dry, well ventilated place, under lock and key so that unauthorized persons do not have access.
